

ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF SANDPOINT, A MUNICIPAL CORPORATION OF THE STATE OF IDAHO, PROVIDING FOR THE AMENDMENT OF SANDPOINT CITY CODE 1-5-2; PROVIDING THAT RULES OF ORDER MAY BE ADOPTED OR AMENDED BY RESOLUTION; PROVIDING THAT ALL REMAINING PROVISIONS OF CHAPTER 5, TITLE 1, SHALL REMAIN IN FULL FORCE AND EFFECT; AND PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SANDPOINT, IDAHO, AS FOLLOWS:

SECTION 1. That Section 2, Chapter 5, Title 1, of Sandpoint City Code be and the same hereby is amended to read as follows:

1-5-2-N: RULES OF ORDER:

1. Procedure: The parliamentary procedure of city council meetings shall be governed by “Parliamentary Procedure Made Easier,” last edition, published by Washington State University, a copy of which is on file in the city clerk’s office.
2. Adoption or Amendment of Rules: Rules of Order may be adopted or amended by Resolution without the need for amendment to City Code.

SECTION 2: That all remaining provisions of Chapter 5, Title 1, shall remain in full force and effect.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.
