These specifications are intended to be precise where a specific brand, make, model or trade name is requested. Whenever a make, model or trade name is used, it shall be that or equal or approved equal. Equal or approved equal means that a different make, model or trade name will be given consideration if it is determined by the City that the different make, model or trade name fulfills the same performance requirements.

This specification is a Brand Name or Equal Specification. This means a specification that uses a brand name to describe the standard of quality, performance, and other characteristics being solicited, and which invites the submission of equivalent products. The use of a brand name herein is for the purpose of designating the minimum standard of quality, performance, and characteristics desired and is not intended to limit or restrict competition. The City reserves the sole right to make a determination on the acceptability of equivalencies and acceptance of other than the brand name specified.

Seller shall supply ownership documents, free and clear, [including Idaho Title Fee \(the prices quoted shall be inclusive of any and all such fees\)](#). Seller shall also supply DMV Transfer of Ownership, Dealers Report of Sale, Bill of Sale or other pertinent documents for the purchase of this vehicle as required by Department of Motor Vehicles for registration.

Vehicle and all equipment furnished therewith shall be in compliance with all provisions of the Vehicle Code, the State of Idaho and the Federal Motor Vehicle Safety Standards.

**INSPECTION AND ACCEPTANCE:** Inspection and acceptance shall be made by the authorized City personnel. Upon delivery, it shall be the supplier's responsibility to provide any evidence necessary that the vehicles fully meet all the requirements of this specification.

The City of Sandpoint reserves the right to accept the bid that represents the greatest value to the City. Considerations will include price proposed, vehicle proposed, the optional equipment included as upgraded equipment, suitability for use by the City, guarantee/warranty, performance specifications of vehicle, year, make, model, etc.
